As such, any change, alteration, addition, etc. to the structure, surfaces, and grounds must have <u>prior</u>, <u>written approval</u> of your Board of Directors.

These changes, additions, alterations, etc. includes such things as decorations, signs, flowers, flower pots, statues, flags, bird houses, thermometers, fences, wind chimes, and a whole host of thingsmajigs. The mind boggles at the variety of things people want to display.

Deed restricted communities have covenants, rules and regulations, and restrictions to affect a clean, pleasant, and somewhat uniform place to enjoy your residence. When you purchased a home in such a community you agreed to abide by the rules. Your Board of Directors, volunteers all, have the responsibility to **enforce the rules**.

Please consult your "documents", including the 2009 version of the Village Woods "Rules and Regulations". Rules are too bothersome? <u>Check the look</u> in a non-deed-restricted community. Please learn the rules and abide by them, attend meetings and ask questions, and get involved with the Board to try to change them.

<u>ANYTHING</u> outside requires prior, written approval from the Board of Directors, unless it is <u>specifically permitted</u> in the Rules and Regulations.

#### **Security Company Yard Signs**

At the February BOD meeting the **sign rules** were modified to allow for the display of security company signs that are backed with a valid, in-force contract.

The <u>approval of an ACR</u> (Architectural Change Request) <u>is required</u> for present and future signs.

<u>Annual renewal</u> with proof of a valid service contract will be required.

If the sign cannot be place next to the hedges, it may be displayed in front of the hedges as long as there is enough room for the hedge trimmers to access the hedges.
